Denali National Park

In 1917, Alaska named its first national park Mount McKinley National Park and nearly 70 years later the park was expanded and renamed Denali National Park. This vast land has a fascinating ecosystem and is more than a park — it is a wildlife reserve. And perhaps its biggest claim to fame is being the home to North America's highest peak, Denali, ascending more than 20,000 feet. This massive park is now more than 6 million acres, an area that can be compared to the size of Massachusetts. The park is home to nearly forty different varieties of mammals, but the most popular residents are moose, caribou, wolves, plus brown and grizzly bears. Denali is Alaska's heartland and brings you up close to its majestic beauty and natural wonders.

Economy air rate and schedule are applicable for groups of 10 or more traveling on the same flights and dates.

Port taxes and fees starting from \$595 USD, quoted at time of printing, per person are not included in the land only tour cost. Single cabins, if confirmed, are higher.

Single accommodations are limited and are available on a first come, first served basis.

Cruise ships have a limited quantity of cabins available in each cabin category. We will make every effort to accommodate your cabin category preference at the time of booking. If the cabin category preferred is not available at the time of booking, the next closest category available will be offered and a surcharge may apply.

Triple accommodations are limited and will be confirmed upon request and availability from the cruise line.

Onboard gratuities are not included in the price of your tour. For your convenience, Princess Cruise Lines automatically applies a 13.50 USD per guest per day service charge to your shipboard account. All of the service personnel on board receive gratuities from this service charge and there is no need for you to think about additional tipping. Separately, a 15% gratuity is added for bar drinks and spa services.

To complete your tour, we include roundtrip airport-to-hotel transfers when purchasing our airfare with your tour. If you have arranged for your own air, we are pleased to provide you the option of *purchasing* these transfers. Please note that all transfers will leave at pre-scheduled times.

Order of ports may be changed by the cruise line.

Some attractions may not be available during the off-season months and is reflected in the price of your tour.

*The Tundra Wilderness tour is a fully narrated 7-9 hour tour, including frequent rest stops. The tour includes a box snack lunch. We suggest that you bring along supplemental food and/or snacks as there are no provisions available for purchase once inside the park.

**On some departures, due to train schedules and availability, the luxury domed rail will be included on day 5 between Talkeetna and Anchorage. When this occurs, the transfer to Mt. McKinley Lodge on day 4 will be via motorcoach.

***Accommodations in Fairbanks will be assigned prior to departure.

Prior to full payment for the program, the cruise line reserves the right to impose a supplemental fuel charge. Should this occur, you will be notified of the additional charges.

The following categories will be utilized when confirming cabin assignments: Balcony Cat BD; Outside Cat OC; Inside Cat ID.

Please be advised many airlines do not provide advance seat assignments until check-in at the airport. Advance seating will be subject to the airline's terms and conditions.

This cruise has ports of call in Canada, therefore a **passport** is required.

This tour requires average physical activity. You should be in good health, able to climb stairs and walk reasonable distances, possibly over uneven grounds and cobblestone streets.

IDENTIFICATION

Travel within USA

All airlines will ask for identification when you check in. It is recommended that you carry a passport if you have one. A driver's license (with a photo I.D.) is also acceptable for domestic flights.

IDENTIFICATION

Passports are required for this tour at your expense. Certain countries require a minimum of 6 months passport validity from date of return home. You are strongly urged to contact the appropriate consulate for details. Visit www.travel.state.gov for the U.S. State Department for the latest details about passports and visa requirements. **IMPORTANT:** We recommend that our clients traveling abroad take a photocopy of their passport and applicable visas. It should be packed separately from your actual passport and visa. We also recommend leaving a copy at home with your emergency contact.

***Airfare:** For your convenience, we offer airfare for purchase with all vacation packages. If you purchase an air inclusive program, your airfare will be quoted inclusive of all fuel, taxes and fees. Your rates are subject to change until paid in full. Seats are limited and may not be available on every flight or departure date.

Checked Baggage Charges: Some airlines may impose additional charges if you choose to check any baggage. Please contact your airline or refer to its website for detailed information regarding your airline's checked baggage policies.

Cancellation Charges for this tour: After your seat reduction date has passed, a non-refundable deposit will be retained. For Cancellation between 60-16 days prior to departure: cancellation fee of 30% of total price. For cancellation between 15-1 days prior to departure: cancellation fee of 50% of total price. For cancellation on the day of departure and after: 100% of total price. For Ocean Cruises: For cancellation between 90-61 days prior to departure: cancellation fee of 35% of total price. For cancellation between 60-31 days prior to departure: 60% of total price. 30 or fewer days prior to departure: 100% of total price. If you chose to partially cancel your vacation, you will be responsible for a revision fee as well as any penalties that are incurred at the time of the cancellation.
